## GENEALOGY OF A BRANCH OF THE CHANDLER FAMILY.

BY MRS. A. M. PICKFORD.

“The Coat of Arms of this Chandler Family was prepared by Miss Fanny Chandler, from an original obtained from the Herald’s College, London, by the Rev. Thomas Bradbury Chandler, D. D. of Elizabeth Town, N. J., when he was there in 1775. The crest borne on the closed helmet above the Coat of Arms, is that of the Pelican in her nest wounding her breast to feed her young with her own blood—an emblem of parental affection expressive of the family motto, ‘Ad mortem fidelis.’ The mantle—cut and jagged—hanging from the Helmet, indicates the faithful service of the wearer; the Gauntlet, his prowess. Heraldic colors on the shield are designated by the direction of the lines. ‘He Beareth Checkie, Argent and Azure, on a Bend o the First, Sa., Three Lyons, Passant, Gules. By the name of Chandler.’” (From Geo. Chandler, of Worcester, Mass.)

1. “WILLIAM CHANDLER and Annis his wife settled, 1637, in Roxbury, Mass. They brought with them four children. Their youngest, Sarah, is the only one whose birth is recorded in this country. What Annis’ surname was before marriage does not clearly appear.” Supposed to be a sister of Deacon George Alcock.

“Annis Chandler was admitted to the church in Roxbury ‘at the same time her husband William Chandler was.’ After the death of Mr. Chandler, she, under the name of ‘Ann,’ m. 2 July, 1643, John Dane, of Barkhamstead and Bishop’s Stortford, Herts, England, and of Ipswich and Roxbury, N. E. ‘Att a Gen’all Co’tte at

Boston, 17th of the 8 mo. 1649.' 'Upon the petition of John Dayne, that the house and land which was Wm Chandler's' be 'Settled upon ye said Dayne, he having paid more debts of Chaners than ye house and land was worth, & also brought up ye children of Chandler w'ch have been chargeable to him.' "

"1649. Oct. 19. In Ansr to the petition of John Dayne ffor the Setling the house and lands of Wm. Chandler (whose widow he marryed and Children brought up) on him, the said John Dayne, his request is granted by this Corte.' John Dayne died in Roxbury, and the church records say he, 'was buried Sept. 14, 1658.' "

Extract from will: "I give to louving wiff Annie whom I mak sooll Exseektria all my movable goods that is not expressed."

"Mrs. Annice (as the apostle Eliot called her) Dane married in Roxbury, 9 Aug. 1660, John Parmenter of Sudbury. His wife Bridget had died the 6th of April previous. John Parmenter had taken the freeman's oath 13 May, 1640. In 1641 he was Selectman in Sudbury." "John Parmenter aged 83, sometime Deacon at Sudbury died 1671 m. 3 d 1." "In 1671 John Parmenter made his will and mentioned his wife Annisce, to whom he gave "the use of my warming pan so long as she remain my widdow." "Mrs. Annis Parmenter died 15 March, 1683. Church records say, "In 1683 m. 1, d. 17 died Old Mother Parmenter a blessed saint."

William Chandler was a small landed proprietor in Roxbury, Mass., as "A note of ye estates and persons of ye inhabitants of Roxbury," made between 1638 and 1640, shows "22 acres—William Chandler—7 persons [in his family]—£06: 00: 00."

He was rated as a "housekeeper." He took the free-man's oath in 1640. The Roxbury Records, as printed in the Norfolk County Journal, say "William Chandler

came to N. E. about the year 1637. He brought four small children: Thomas, Hannah, John, William; his fifth child Sarah was born here; he lived a very religious and godly life among us, and fell into a Consumption to which he had, a long time, been inclined; he lay near a year sick, in all which time his faith, patience & Godliness & Contentation So Shined that Christ was much glorified in him—he was a man of Weake parts but Excellent faith and holiness; he was a very thankful man, and much magnified Gods goodness. He was poor, but God prepared the hearts of his people to him that he never wanted that which was (at least in his Esteem) Very plentiful and Comrortable to him—he died—in the year 1641, and left a Sweet memory and Savor behind him. The Eliot Church Records say, “William Chandler, a Christian, Godly brother, died of a Consumption month 11, day 26, 1641, and was buried 29(11) 1641, in Roxbury.” The children of William and Annis Chandler were:—

2. HANNAH,<sup>2</sup> b. about 1629; m. first, Dec. 12, 1646, (say the Eliot Church Records of Roxbury in the handwriting of John Eliot the Apostle) George ABBOT, who emigrated from Yorkshire, England about 1640; lived in Roxbury, awhile; settled in Andover in 1643. She m. secondly, 1690, Rev. Francis DANE, of Andover, between 1684 and 1703. “The parties are said to have come to America on the same ship. Mr. Abbot died in Andover Dec. 24, 1681, at the age of 76, being, as he says in his will, “aged and crazy in body.” She outlived Mr. Dane and died June 11, 1711, aged 82. (Essex Antiquarian, I. No. 3, p. 1.) Children born in Andover:—

JOHN,<sup>3</sup> b. March 2, 1648; deacon of the South Church and selectman of the town; m. Sarah Barker of Andover, Nov. 17, 1673; d. March 19, 1720-21. His wife died February 10, 1728-9, aged eighty-two.

JOSEPH,<sup>3</sup> b. March 11, 1649; d. June 24, 1650.

HANNAH,<sup>3</sup> b. June 9, 1650; m. John Chandler, Dec. 29, 1676; d. March 2, 1740.

JOSEPH,<sup>3</sup> b. March 30, 1652; killed by Indians at Andover, April 8, 1676.

GEORGE,<sup>3</sup> b. June 7, 1655; was a selectman of Andover, where he resided, and a man of Christian character; was Captain; m. Dorcas Graves, April 17, 1678; d. Feb. 26, 1735-6. His wife survived him, and died his widow, Feb. 18, 1739-40, "being aged."

WILLIAM,<sup>3</sup> b. Nov. 18, 1657; a weaver and lived in Andover; had the Puritan faith; m. Elizabeth Geary of Roxbury, June 19, 1682. She died Nov. 26, 1712; he died Oct. 21, 1713.

SARAH,<sup>3</sup> b. Nov. 14, 1659; m. Ephraim Stevens, Oct. 11, 1680; d. June 28, 1711.

BENJAMIN,<sup>3</sup> b. Dec. 20 1661; a carpenter and lived near the Shawshene river in Andover, and was an active and respected citizen; was corporal; m. Sarah Farnum of Andover, April 22, 1685. His wife survived him, and was living his widow in 1724.

TIMOTHY,<sup>3</sup> b. Nov. 17, 1663. April 8, 1676, he was taken; captive by the Indians, and in the following August was returned by a friendly squaw, having suffered much hunger. He was a husbandman and lived in Andover; m. Hannah Graves, Dec. 27, 1689. She d. Nov. 5, 1726; and he d. Sept. 9, 1730.

THOMAS,<sup>3</sup> b. May 6, 1666; was a farmer and lived on the west side of the Shawshene river in Andover; m. Hannah Gray, Dec. 7, 1697. She was born Nov. 30, 1674, and died his widow Jan. 25, 1763, aged 89. Mr. Abbot died as he had lived, a Puritan in faith, April 28, 1728.

EDWARD,<sup>3</sup> drowned when young.

NATHANIEL,<sup>3</sup> b. July 4, 1671. He was a wheelwright and resided in Andover; m. Dorcas Hibbert, Oct. 22, 1695. She died Feb. 16, 1743, and he died Dec. 1, 1749, aged 78.

ELIZABETH,<sup>3</sup> b. Jan. 29, 1673-4; m. Nathan Stevens, Nov. 24, 1692; d. May 4, 1750. (*Essex Antiquarian*, I, No. 3, pp. 35-37.)

3. Capt. Thomas,<sup>2</sup> b. 1630; m. Hannah Brewer, Andover. She died there Oct. 25, 1717. He came with his parents to this country in 1637, when he was about seven years old; was one of the proprietors and early pioneers in the settlement of Andover; Representative to the General Court, in 1678-9, from Andover. "He died 15 day 1703." Children:—

THOMAS,<sup>3</sup> b. Oct. 2, 1652; d. June 6, 1659, aged 7 years. (Salem Record.)

JOHN,<sup>3</sup> b. March 14, 1655 at Andover; m. Dec. 20, (O. S.) 1676, Hannah Abbott; d. in 1703. She d. in 1717, aged 87.

HANNAH,<sup>3</sup> m. Dec. 2, 1674, Daniel Bisby of Andover. He d. May 7, 1717.

WILLIAM,<sup>3</sup> b. May 28, 1659; m. April 21, 1687, Elanor Phelps. They were the first couple married by Rev. Francis Dane of South Andover.

SARAH,<sup>3</sup> b. Dec. 20, 1661; m. Samuel Phelps, Sen. of Andover; he d. Jan. 26, 1746, aged 95. She d. April 5, 1757. Member of church in South Andover which she joined Jan. 25, 1713.

THOMAS,<sup>3</sup> b. Oct. 9, 1664; m. Mary Peters, May 22, 1686. She d. July 21, 1753, aged 85. He d. Jan. 20, 1737, in 73d year; was representative to the General Court.

HENRY,<sup>3</sup> b. May 28, 1667; m. Nov. 28, 1695, Lydia Abbot of Andover. She was b. Sept. 29, 1675; d. March 11, 1739, aged about 74. He d. Aug. 27, 1737, aged 71.

JOSEPH,<sup>3</sup> b. Aug. 3, 1669; m. Sarah Abbot, Nov. 26, 1691; was captain.

5. JOHN,<sup>2</sup> m. "ffeb. 16, 1658." Elizabeth Douglas (b. 1610; d. at New London, Conn., 7.. 23.. 1705.), was deacon of the church; d. April 15, 1703; buried in Woodstock, Conn. Children all born in Roxbury.

JOHN,<sup>3</sup> b. March 4, 1659; d. Dec. 15, 1660.

ELIZABETH,<sup>3</sup> "borne ffeb<sup>r</sup> 20, 1661; m Robert Mason of Roxbury, Nov. 18, 1680. She d in Roxbury, Nov. 17, 1688, in her 27<sup>th</sup> year.

JOHN,<sup>3</sup> b. April 16, 1665; m. first, Mary Raymond of New London, Conn., Nov. 10, 1692. She d. "April y<sup>e</sup> 8<sup>th</sup> 1711. He m 2dly Esther Britman, Nov. 14, 1711. She was widow of Palsgrave Alcock. He was Captain, the Col. He was nearly forty years a Commissioners of the Peace; seven years of His Majestys Council. Was also Judge." Judge John Chandler died in Woodstock, Conn., Aug. 10, 1743.

JOSEPH,<sup>3</sup> b. April 3, 1667; d. "month 8, day 1, 1668."

HANNAH,<sup>3</sup> b. Sept. 18, 1669; m. Moses Draper of Roxbury July 7, 1685. She d. June 9, 1692, aged 22. He d. May 19, 1693.

MEHITABLE,<sup>3</sup> b. Aug. 24, 1673; m John Coit of New London, Conn., June 25, 1695. He was b. Dec 1 1670; d. Oct. 22, 1744, at 74. She d. Nov. 3, 1759 in her 87<sup>th</sup> year.

SARAH,<sup>3</sup> b. Nov. 19, 1676; m. William Coit of New London, Conn., June 9, 1697. He was b Jan. 25 1675; d. May 7, 1703, aged 27. She m. 2dly. John Gardner, Sept. 7, 1708 (b. April 19, 1661, d. June 25, 1738 aged 78); she d. July 3, 1711.

JOSEPH,<sup>3</sup> b. June 4, 1683; m Susannah Perrin of Roxbury June 29, 1708; was Captain and selectman; d in Pomfret Jan. 5, 1749-50 in his 67<sup>th</sup> year. She d. Jan 22, 1775 in 68<sup>th</sup> year.

6. SARAH,<sup>2</sup> b. in Roxbury; m. first William CLEAVES, Nov. 4, 1659. He was killed by the Indians at Sudbury, Mass., April 29, 1676. She m. 2dly, Wilson; 3dly, Oct. 11,

1688, Eph. Stevens; 4thly, Allen. Children by her first husband:—

SARA,<sup>3</sup> b. Aug. 12, 1660.

ELIZABETH<sup>3</sup>, bapt. "1671, month 12 day 17 "

" MARGARET<sup>3</sup> Parker, dau. to Widow Cleaves took hold on the covenant 1679 m 9 d 17."

" HANNAH<sup>3</sup> Cleaves (and others) took hold on the Covenant this day 1681 m 1 d 20."

4. WILLIAM<sup>2</sup> (*William*<sup>1</sup>), b. probably in England, m. first Mary Dane. She was born in Ipswich, Mass., in 1638, and died May 10, 1679, at Andover, Mass; was the daughter of Dr. John Dane, "the chiriergen", who was probably born at Barkhampstead, England, about 1612, and died at Ipswich, Sept. 29, 1684, by his first wife Elanor (Clark). This Mr. Dane was author of "A Declaration of Remarkabell Prouedenses in the Corse of my Lyfe." which was reprinted in the N. E. Hist, and Gen. Register (VIII. p. 149) for 1854. He was son of John Dane, of Barkhampstead and Bishop's Stortfort, Herts, England, and of Ipswich and Roxbury, Mass. He married for his second wife, Annis Chandler, the widow of William Chandler, Sen; and mother of William Chandler, Jr., above named.

He married secondly, Bridget Henchman, Oct. 8, 1679. She was the widow of James Richardson. She died March 6, 1731. Her pastor, Rev. Samuel Phillips, says she attained the age of 100 years. William Chandler was admitted freeman in 1669. He kept an Inn on the Ipswich road to Billerica. The sign was a "horse shoe". He was "licensed 17 day of June 1692, by their Majesties Justices at a Gen Sessions", at Salem. He died in 1698, in Andover aged about 64 or 65. Extracts from his will dated September 15, 1697.

Imp<sup>r</sup>. I give unto my beloved wife Bridget ye one half of all my housing, Orchards, Gardens Pastures Mowing Grounds, and arable lands, viz my homestead with half a piece of meadow lying vpon

Foster brook . . . . . and this I give to her During the time she shall Remain My Widow ; further I give to my beloved wife two cows and six sheep, and one swine : also I give to her ye ffeather bed that I Now lye on w<sup>th</sup> all Comfortable ffurniture belonging to s<sup>d</sup> bed. I give her also one Grat brass Kettle, one little kettle, one Iron Pott, one Pewter quart Pott, a Pewter Lym brek, two Pewter Platts, one pewter cup, one brass with one Stien, one pair of Tongs, w<sup>th</sup> Suitable necessities as to Lumber. This for her to Injoy During her Natural Life, obliging my said wife to a Careful vse of Said things, and then to be Returned into y<sup>e</sup> hands of my Executors.

It. I give my Sons forty pounds apeace.

It. I give my Son William all my Meadow vpon ye East side of Shaushin River. . . .

It. I give to my s<sup>d</sup> Son William A tract of land that I fformally bought of Samuel Hutchinson . . .

Also, I give to my S<sup>d</sup> son five acres of vpland that I formerly bought of Thomas Osgood. All his vpland and Meadow I value to be worth fifty pounds—obliging my Said Son to pay Ten pounds to my Executers. . . .

It. I doe also constitute and appint my beloved wife and my Son William and my llouving friend John Barker to be my Executors to this my last Will. . . .

William Chandler declined serving as executor.

WILLIAM<sup>4</sup>, b. July 14, 1704; m. 1st. Elizabeth Blanchard (d. July 15, 1735) Nov. 22, 1725; m. 2dly March 4, 1736, Mary Holt (d. June 17, 1756) both of Andover; d. April 15, 1741.

JAMES<sup>4</sup>, b. June 10 1706; m. in Salem, Mary Hale, Nov. 14, 1736; was a minister in Byfield; served in the War of the Revolution from Rowley; d. April 19, 1789, aged 83. She d. Sept. 2, 1806, aged 92.

PHEBE<sup>4</sup>, b. 1707; m. Caleb Dana July 14, 1726. He d. May 4, 1769, aged 73.

LYDIA<sup>4</sup>, b. 1709, m; Ebenezer Felch of Reading, May 17, 1728; d. May 23 1731. He m. 2dly Margaret Toothaker, of Billerica, Jan. 28, 1734.

BRIDGET<sup>4</sup>, b. 1711; d. Oct. 22, 1711.

BRIDGET<sup>4</sup>, b. 1711; bapt. Sept. 14, 1712; m. Josiah Wood of Rowley, June 3, 1731; d. Dec. 25, 1754, aged 54. He d. March 25, 1753, in his 50th year.

HANNAH<sup>4</sup>, bapt. Dec. 19, 1711; m. George Burroughs of Charlestown, May 10, 1733, was his third wife, d. Sept 1757. He was lost on a voyage to Europe, was a descendant of the minister, Rev. George Burroughs, who was executed on Gallows Hill Salem, Aug. 19, 1692, for witchcraft.

JOHN<sup>4</sup>, b. Feb. 13, 1717; d. Feb. 23, 1717.

ELIZABETH<sup>4</sup>, b. May 15, 1718; m. John Dane, Jr. May 29, 1739. He was a son of John and Sarah (Chandler) Dane and was b. Nov. 20, 1716; d. June, 1801 aged 85; was Deacon of the South Church, Andover.

JOSEPH<sup>4</sup>, b. 1720; m. Mary Abbot, Oct. 4, 1742; d. March 31, 1745, aged 25. She was b. April 13, 1725, dau. of Ebenezer and Hannah (Dane) Abbot; m. 2dly Isaac Blunt of Andover.

JOHN<sup>4</sup>, b. Dec. 14, 1723; m. 1st Mary White of Haverhill, Nov. 3, 1748. She d. June 28, 1757 aged 31. He m. 2dly Elizabeth White of Haverhill, was ordained pastor of the church in Billerica, Oct. 21, 1747; graduated from Harvard College in 1743; d. Nov. 10, 1762 in his 39th year.

**17.** PHEBE<sup>3</sup>, b. Sept. 17, 1680; m. Jonathan TYLER. She was called as a witness at the trial of Martha (Allen) Carryer, who was tried for witchcraft in Andover, Aug. 2, 1692, and who was condemned and hanged Aug. 19. Phebe was not then twelve years old. She testified:—

That about a fortnight before the apprehension of Martha Carryer, on a Lord's day, while the psalm was singing in the church, this Carryer there took her by the shoulder, and shaking her, asked where she lived. She made no answer, although Carryer, who lived next door to her father's house, could not in reason but know who she was. Quickly after this as she was several times crossing the field, she heard a Voice that she took to be Martha Carryers and it seemed as if it were over her head. The voice told her she should within two or three days be poisoned, accordingly, within such a little time, one half of her right hand became greatly Swollen and very painful, as also a part of her face; Whereof she can give no account how it came. It continued very bad for several days, and several times since she has had great pain in her breast: and been so seized on her legs, that she has hardly been able to go.

MEHITABLE<sup>4</sup>, b. in Andover; m. 1st. Feb. 7, 1732, Robert Crosby of Billerica; m. 2dly Andrew Spaulding, Nov. 26, 1745. He was a deacon.

THOMAS<sup>4</sup>, m. Elizabeth Walcott of Andover, Feb. 15, 1739; d. at Reading, Dec. 11, 1760, aged about 50 years.

MARY<sup>†</sup>, b. March 4, 1713, m. James Holt of Andover Oct. 22, 1733; d. Feb. 10, 1751, in her 38th year. He m. 2dly Mrs. Mary McIntire, Aug. 6, 1767.

PHEBE<sup>†</sup>, d. May 13, 1737, aged 23 years.

In the Name of God Amen; The Twenty Sixth day of June anno Dom: one Thousand Seven Hundred and Twenty-two, I William Chandler of Andover. . . Nextly I give to Sarah my well Beloved Wife the use of my Homestead Land & Buildings while she Continues my Widow; also three pound pr annum to be paid her by my three Sons, That is Twenty shill: apiece yearly, During her Natural Life; also Two Cows to be at his dipose, and as for Household stuff, I give her So much as she has need of, also fire wood she shall need for her own use; and order my Son Philimon to Convey her hither and thither.

Item. I give to my Eldest and well beloved Son Josiah (besides what is already Conveyed to him by Deeds) my Cloak, and a third part of my Cloathing besides ye Cloak, also a pair of Cattle, and a third part of my Husbandry and House Tackling, and a third part of what money I shall Leave undisposed of, and pair of hand-irons, Which Completes his Portion.

Item. I give to my well beloved Son Philimon (besides what is already Conveyed to him by Deeds) my Riding-horse, and his choice of a pair of Cattle, also a third part of all my Husbandry & house tackling, also a Third part of what money I shall Leave undisposed of, & a third part of my clothing. . .

Item. I give to my youngest and well beloved Son Zechariah (besides the Two hundred and Ten pounds in bills of credit, already

received) a pair of cattle, a Gun, and Iron bar, also a third part of my Husbandry and House tackling, and a Third part of what Money I shall leave undisposed of, and a Third part of my Cloathing.

Moreover, I leave to my s<sup>d</sup> Three Sons between them, One bed well furnisht w<sup>th</sup> Curtains, sheets, blankets and a Covering besides. also I give them all my Hogheads and Barrels to be equally divided between them. And if anything be found not disposed of to another I order the same thing or things to be equally divided between my s<sup>d</sup> three Sons.

Item I give to my well beloved Daughter Sarah (besides the fifty pounds already given her) all my household goods & moveables not dispos<sup>d</sup> of to my Sons, Such as pewter, brass, Ironware, bedding, Linen, Chefts, &c, or what my wife has not occasion for, to be my Daughter Sarahs. . .

And further know all men by these presents that I constitute and appoint Sarah, my wife and my sons Josiah and Philimon Executors of this my last Will & Testament. . .

Item I give to my well beloved Wife Sarah Chandler the usse of my household Stuff or goods so much as she shall stand in need of during the time she remaining my widow, my said wife accepting the same, with what I have hereafter Willed my Executor hereafter named to do for her In Liew of her right of Dowry in my Estate and not Otherwise

Item I give to my Son Benja Chandler a Sum of Forty pounds in bills of credit of the old Tenor according to the present value of [ ] or equivalent thereto in any other payable Specie To be paid him in the Space of two years after my decease By my Executor hereafter named, which sum, with what he hath already had, is all ye portion I intend him out of my estate—Item I give to my Son Josiah Chandler the sum of Forty Pounds in bills of credit of the old Tenor, according to the present value or its equivalent thereto in any other passable Specie to be paid him in the Space of three years after my Decease by my execut<sup>r</sup> hereafter named, which Sum with what I have already given him is all the Portion I intend him out of my Estate

Item I give to my Son Samuel Chandler y<sup>e</sup> Sum of twenty Shillings . . . to be paid him in the space of twelve months after my decease . . . which sum with a Liberal Education which I have Given him at the University in Cambridge is all the portion I intend him out of my Estate . . . I give to my daughter Sarah Chandler y<sup>e</sup> sum of one hundred pounds . . . the said sum to be paid, and alsow delivered To her at Marriage, or if she do not marry in the Space of three years after my Decease . . . To my Son Abijah Chandler the Sum of three hundred pounds . . . the said sum to be paid at my Decease . . . my sd Son having been helpful to me in the management of my affairs for several years Since he came of age . . . To my Son David Chandler who for several

years has been in my service, at all times acquitting himself faithfully and in Confidence of his being a Comfort to me In my old age, and in Consideration of what I have Willed him to do for my beloved wife and my other children . . . all my Land and Buildings of Every denomination whatsoever that I have in the Township of Andover aforesaid also all my Stock of brute Creatures of what name or Denomination Soever, also all my utensils or Tackling for carrying on of husbandry Business Also all my money or Bills of credit And Bonds or Notes of hand, Also all my Just Dues on book of Accounts . . . I give to my son Daniel Chandler y<sup>e</sup> sum of one hundred and twenty pounds . . . at my Decease. Item I Will that my wife aforesaid shall have y<sup>e</sup> use & Improvement of the west halfe of my dwelling house, and so much Cellar room as she shall have Occasion for, not excluding my son David the one halfe or more if my said wife shall not stand in need of the same during the time she abides my widow. Item I Will that my Executor hereafter named shall provide my aforesaid wife the Necessary Comforts of life Vizt Eight bushels of Indian Corn four bushels of rye. One hundred weight of good pork & sixty weight of beef and four barrells of cyder and two bushels of meal yearly during the time she remains my widow. Also Salt necessary for her use & sauce both Summer and Winter. Also a good Cow well kept Summer & Winter Also fire wood ready cutt at the Door, Also clothing what she shall have need of for her own use and Also Physick & proper attendance in case of sickness. Also a good serviceable horse & horseman to Carry her to meeting or else where of she shall have occasion During the Time she remains my widow, and the abovesaid to be at her own Dispose.

Item It is my Will that my Wearing apparil be equally divided between all my children after my decease. Lastly I Do hereby Constitute my son David Chandler the only Sole Executor of this my last Will and Testament . . . eighteenth Day of February Anno Domini one thoufand seven hundred & forty Eight nine . . .

26. SAMUEL<sup>5</sup> (*Josiah<sup>4</sup>, William<sup>3</sup>, William<sup>2</sup>, William<sup>1</sup>*), was born in Andover in 1713; bapt. July 5, 1713. He married September 12, 1738, Ann or Anna Pecker of Haverhill. She was daughter of Capt. John and Eliza (intention reads) Elizabeth (Kelly) Pecker, was born January 3, 1715, and died September 6, 1778, aged 63. Her mother in her journal says; "September 16-1778 this Day my Dear & Honrd Mother was taken from me . . . Aged 60 years."

Samuel Chandler graduated at Harvard College in 1735. He was ordained pastor of the Second Church, York, Maine, January 1, 1742, and taught school part of the time in addition to his ministerial duties. Mr. Chandler left York for Gloucester, Mass., arriving there Saturday, Feb. 23, 1751, and preached the next day. His forenoon sermon was from Isa. LV. On November 13, following, he was installed as colleague to the Rev. John White, pastor of

the First Church in Gloucester. The sermon was preached by Rev. Samuel Phillips of Andover from Luke XIV. 21. Rev. Mr. White died Jan. 16, 1763, and Mr. Chandler took his place as pastor of the church. "The parish agreed to pay him a salary of eighty pounds per annum, and to let him have the use of the parish land. They also voted to provide him a suitable house, barn and garden, in a convenient place." Mr. Chandler owned at the time of his death, the gambrel roof house, still standing, on the south side of Middle Street, about midway between Short and Centre Street. He moved into it March 20, 1752.

"In 1755, Mr. Chandler, with the unanimous consent of his church, went as chaplain in Col. Plaisted's regiment in the expedition against Crown Point. He was engaged in the service from Sept. 8 to Dec. 28. The next Spring Col. Plaisted came to Gloucester on purpose to secure his services for the campaign of that year, but the parish would not consent to his going . . . The declining days of Mr. Chandler were rendered painful and wearisome by long sickness and suffering; but no bodily infirmity or distress could move him to sorrow or repine.

He was a gentleman of clear apprehension, solid judgment, firm, and of a thoughtful, inquisitive temper of mind. These, sanctified and improved, fitted him for the high and honorable office he sustained, and which he discharged with fidelity. As a preacher, he delivered the truth as it is in Jesus; showing in his doctrines incorruptness, gravity and sound speech, that could not be condemned; exhibiting a bright example of the same in the course and tenor of his life. He was blessed with a great degree of wisdom and prudence, the happy effects of which have been evident in a variety of instances. The welfare of his people and of the church of God lay very near his heart. He was a warm friend to his country. In every relation he maintained the character of a sincere disciple of his Lord and Master the Lord Jesus Christ. Many and various were his trials on his passage through life, under which his patience was conspicuous. Under the hand of God, in the consumption which closed the scene

of life, he discovered great submission and resignation to His holy will, who was his staff through the valley of the shadow of death, and now is (as I trust) his portion forever."

Tradition confirms all that is here said of Mr. Chandler. His domestic life was one of singular infelicity; and the reports concerning it, not yet passed into oblivion, render it probable that the gentleness, patience, and resignation that marked his character were schooled to a severe exercise in his conjugal and parental relations. His wife to whom he was married in 1733, was Anna Pecker of Haverhill, who had either a disordered intellect or a perverse heart—She annoyed and troubled her husband in unusual ways; and, in the judgment of charity, it may be allowed that reason rather than conscience was deficient. Mr. Chandler had a son John, who was a seafaring man, and is said to have caused his father much anxiety and trouble; but of his history and end no particulars are preserved. He also had a daughter Anna, whose conduct was the source of less happiness than sorrow; but her frailties were buried with her in an early grave. She died Feb. 19, 1765, of consumption, aged twenty-two. (Babson's History of Gloucester, 327-330.)

Mr. Chandler died March 16, 1775, in the 63d year of his age and the 24th of his ministry in Gloucester. He is buried in the old graveyard in Gloucester. Inscription on stone:—

To the memory of the Rev<sup>d</sup>  
Samuel Chandler, Pastor of  
The First Church of Gloucester  
who died  
April 16<sup>th</sup>, 1775. Æ 62.  
The Memory of the Just is Blessed.

The stone is numbered 542 near Rev. Mr. White, North and West part of yard. Mrs. Chandler, after her husband's death, opened a small shop in the house where she had long resided on Middle Street; and after keeping it a short time, removed out of town. In his will of March 2, 1775, he said:—

"I Samuel Chandler of Gloucester . . . to my wife her Right of Dowry in my estate as though I had left it intestate. To my children John, Samuel and Sarah, wife of William Haynes, I give all my real estate, viz. my Dwelling House in s<sup>d</sup> Gloucester, land, &c. . . . . Of my household furniture, I give one Feather bed and bedding to Elizabeth, Daughter of my Daughter Anna Dec<sup>d</sup> to be delivered to her at full age, or upon her marriage. The remainder of said furniture I give equally to my Daughter Sarah and to the s<sup>d</sup> Elizabeth. I also give to s<sup>d</sup> Elizabeth £15 lawful money, 5 to be paid by John, 5 by Samuel and 5 by my daughter Sarah. I appoint Samuel Whittemore and my son Samuel Chandler to be executors of this my will.

Approved April 23, 1775. Inventory £220 : 7 : 2.

### Extracts from diary of Rev. Samuel Chandler :—

Nov. 20, 1745. I preached Lam. 3. 40 . . . went to Deacon McIntire's. In the night towards the latter part of it, my wife seemed to be much affected—panting, heaving and short breathing. I asked her "what was the matter?" several times, but she made no reply. I thought she might be asleep and had not opportunity to inquire further till the next Evening, when she told me she was awake but could not speak. She had dreamed of her following her father to his funerall, and he looked angry upon her which brought to mind her undutifulness which was very greivous to her under the views she had then, and led her to consider step by step her sinfulness and misery, till the Excellency of Christ was presented to her which overcame her with love. She says she endeavoured to show what she was—the worst of herself that she might not be thought a Hypocrite. She has distressing fear of the Devil. She has a great sense of her—to be saved—much deed<sup>s</sup> and backw<sup>d</sup>s to duty Lamented her former life and abuse of friends—I gave her my best advice and counsel.

Dec. 10, 1745. Father Pecker came to see us.

Jan. 6, 1746. I visited Daniel Jink's wife sick of a Fever—her senses something Broken and Shattered.

July 7, 1746. About 5 o'clock in the morning my wife sent out for the women. Brought to bed with a Daughter about 11 o'clock morn.

22. In the morning about 8 o'clock on 2d part our infant Babe departed this life.

March 31, 1762. Attended the family meeting of Elder Warner's my wife there, we talked over the affair of having our friends come and see us and make a family visit—appointed next Wednesday.

April 7, 1762. A number friends came to see us on a Special visit to converse and hear in order to consider and advice or devise what means may be used for redress. . .

April 11, 1762. My wife so out raneous I confined her.

April 12, 1762. Confinement continues.

April 15, 1762. Confinement and calm—an airing once or twice a day.

April 17, 1762. I was at home all day, some try alls.

April 20, 1762. I rode out with my wife in the morning.

April 21, 1762. I had Slacked as to confinement—gave more liberty; but to-day upon some old complaint made to a Girl who came here, I confined close—Some reflections, short answers—a little haughty and imperious.

May 2, 1762. This morning confined my wife.

May 4, 1762. Coming home in the Evening some try'all.

July 21, 1764. I was very much not well but great try alls at night went to bed, but was obliged to get out again my wife quite out raneous, smiting, pinching, pulling hair &c.

Nov. 25, 1764. Gt. confusion at home.

Nov. 29, 1764. Thanksgiving. Much confusion. I ate but little. I left the table.

Dec. 10, 1764. After dinner began confinement. Changed rooms.

Samuel, then of York, Maine, said in his diary June 19, 1746: "My Brother, Abijah, came out a Soldier and lodged with me, & James Silver . . . my brother Abijah here got a discharge from being a Soldier." He d. in Woburn, May 6, 1754, aged 35, buried in Andover. Inscription on stone:—

**30.** DAVID<sup>5</sup>, b. Dec. 15, 1724; m. Mary Ballard, Aug. 30, 1750; both of Andover. He was a corporal in the 2d Military Company in Andover, April 23, 1757, under Captain Jonathan Abbot. In 1762 he was an ensign in Captain Benjamin Ames's Company of Militia; and at the Battle of Bunker Hill, June 17, 1775, he was Lieut. in the same Captain's Company. He died Feb. 11, 1776, in camp at Cambridge, of small pox in his 52d year. She m. 2dly, David Parker of Reading, Nov. 10, 1779. Children:—

JOSIAH<sup>6</sup>, b. Jan. 22, 1762; m. at Bedford, Jan. 15, 1787, Margaret Aiken, of Bedford, N. H. She was b. at Bedford, June 10, 1767; d. April 17, 1740, in her 73d year.

BALLARD<sup>6</sup>, b. Jan. 23, 1765; bapt. Jan. 25, 1765

JOHN<sup>6</sup>, b. July 4, 1771; m. Abigail Hay, of South Reading. She was b. 1771; d. June 20, 1787.

MARY<sup>6</sup>, b. Oct. 27, 1773; m. Feb. 17, 1791, Daniel Foster, both of Reading. He d. Oct. 15, 1811. She d. Oct. 11, 1826.

**31.** DANIEL<sup>5</sup>, b. Aug. 8, 1727; d. March 27, 1752, of fever. Administration on his estate was, April 13, 1752, granted to his father, JOSIAH<sup>4</sup>, of Andover; but he having died on August 12, it was granted to his brother Josiah<sup>5</sup>, of Bradford, who as administrator *de bonis non* made oath to the following inventory:—

Old Mill Prison, Plymouth, England, May 7, 1777. Fourth remove from the Burford to the Blenheim of 90 guns. On board the ship we met with Capt. Brown's officers and people and other prisoners to the No. of 180. Capt. Southward of Salem, and two Mr. Chandlers of Cape Ann among the No.

May 20. John Chandler (mate of Capt. Tilestone) Samuel Chandler his brother, passengers in the same Vessel.

June 15. The two Mr. Chandlers obtained their liberty, John being invalided, Samuel being a passenger in the brig. (General Journal, April, 1778).

His father refers to him in his Journal under different dates:—

1760, May 16. John went to Marblehead and shipped in the Stork, Capt. Foster.

1761, April 30. John sailed for the Banks.

Nov. 7. John came in from the Banks.

1761, Feb. 10. Afternoon John came in. Passenger on Capt. Jacob Allen. He has been taken by the French & been put on board the man of war.—was ab<sup>s</sup>t 6 weeks and . . . left her and swam ashore.

December 2. I was at home. John went up to Salem on foot & came home next morning before meeting time.

1763, Feb. 12. Capt. Nichols Sailed. My Son goes out about 2 oth clock afternoon. Smart wind N. West.

1763, May 26. John got home in 42 days from Lisbon.

June 11. John sailed for the West Indies with Mr. M. Austins goes mate in a Small Schooner in Mr. Smiths employ. Pretty Thick weather this morn. wind to South. They sailed at 10 o'clock morn.

His sister, Sarah (Chandler) Haynes, in her journal says:—Gloucester July the 8, 1779. this Day in Boston Departed this Life my oldest Brother after languishing 6 months Aged 41 years.

**34.** ANNA<sup>b</sup>, b. at York, Maine, March 8, 1742; d. Feb. 19, 1765, of consumption, aged 22 years. From her father's journal:—

August 27, 1761. Anna came home from Boston.

Feb 19, 1764. I was at home all day with my 2 Daughters, no meeting; I prayed and read.

June 2, 1764. Anna went to Boston. (She had resided there a year or two.)

June 30, 1764. Anna began to fail.

Mr. Samuel Chandler

He graduated at Harvard in 1775. Went on a voyage privateering, from Newburyport, after which he taught a mathematical school in that town. He possessed a literary taste which he had cultivated by education. He was a quiet peaceable citizen and much respected. His widow married John Maycall, whom she outlived, and died at an advanced age. Extract from his sister's journal :—

May the 25<sup>th</sup> 1786. this Day (in Newburyport) Departed this Life in a full Sure and Sartan Hope of a Glorious Resarexssion my Dear & only Brother Aged 33 years.

The following letter, now in possession of Mrs. Pickford, was written by him to his father, Rev. Samuel Chandler :—

BYFIELD, November 5, 1767.

*Honored Father.*

I take this Opportunity to Write to You, to let you now, that I am well, and hope you Enjoy the same. I mist sending by M<sup>r</sup> Barson's my Master says that I must come Home Thursday fortnight before Thanksgiving. Sir plese to send to Boston the first Oppor-tunity for me a Eutropius. Remember my love to brother a Sisters, so no more at present.

This from Your Dutiful Sun

SAMUEL CHANDLER.

His father wrote in his journal under date of Aug. 26, 1761 :—

I was at home all day alone with Sammy.

His widow went to live in Chelsea with her brother. He went to sea about 1828 in his own vessel and was lost. His occupation in Medford is given as shipmaster. He left a daughter, Elizabeth<sup>8</sup>, who m. Isaac A. Hatch, of Bangor, and died in 1857, aged 32.

**36.** SARAH<sup>6</sup>, (*Samuel<sup>5</sup>, Josiah<sup>4</sup>, William<sup>3</sup>, William<sup>2</sup>, William<sup>1</sup>*), was born in York, Maine, October 22, 1747; m. Capt. William Haynes, probably son of <sup>Samuel</sup>William and Hannah Haynes of Brunswick, Maine, August 16, 1769. He was born at Brunswick, July 1, 1743. He was a sea captain.. He sailed from Boston and it is supposed that he was lost at sea with all his crew. She died at the residence of her daughter, Sarah (Haynes) Mann in Providence, where she was visiting, February, 28, 1813, aged 66. Buried in Providence. Extracts from the journal of Sarah (Chandler) Haynes, younger daughter of Rev. Samuel Chandler. Journal owned by Mrs. Pickford.

Gloucester, March the 16<sup>th</sup> 1775. This Day my Dear and Hon<sup>r</sup><sup>l</sup> Father quited his Earthly Tabernacle & entered a House not made with Hands Eternal & on High . . . may we indever to follow the Pious Example of his unblemished Life. May the Father of all Mercy be a Father to the Fatherless & a Husbon to the Widow . . . He Died in the 63 year of his age in a consumption.

September the 16<sup>th</sup> 1778. this Day my Dear & Hon<sup>r</sup><sup>l</sup> Mother was taken from me & from the world after a Short Sickness Aged 60 years—Now Father & Mother have forsaken me may the Lord take me under his Parental Care . . .

October the 57<sup>th</sup> 1786. this Day my Dear & much Love child Polly was taken from me. She died with the throat distemper Aged 4 years and 5 months. She was Born the 23<sup>rd</sup> of May 1782 thursday morn 10 clock.

November the 25<sup>th</sup> 1787 this Day Departed this mortal Life & entered a Blessed Immortality my Second Daughter Nancy Haynes Aged 12 years & 3 months. She was Born August the 31<sup>st</sup> 1775 at 4 clock P. M. while she was carefully attending the Sick Bed of her Sister and endeavoring to comfort & Sooth the Sorrow of her afflicted Mother with the Rose blooming on her cheek & Health Sparkling in her Eyes She was Sez<sup>d</sup> with the Scarlet Fever which carred he of in 2 Days living her Destressed Mother & Sick Sister to mourn her Excete conpyh of her Spotless Life. She met Deth with a Smile . . . (I have a sampler nearly completed, a little end of silk hanging where she took the last stitch. A. M. P.)

June 1799. My only child is married (Sarah Chandler Mann) & in that have I not many things to be thankful for is she not living & 3 promising grand children which are the delight of my heart & may Still be comfort to me. But above all have I not great & good reason to believe I have two children & a husband & other relations in Heaven . . .

October 1807 Thursday 22 This Day I enter my Sixty first year . . . Father & Mother Brother & Sister Husband & children are all Gon before me. Only one child remains & her children . . .

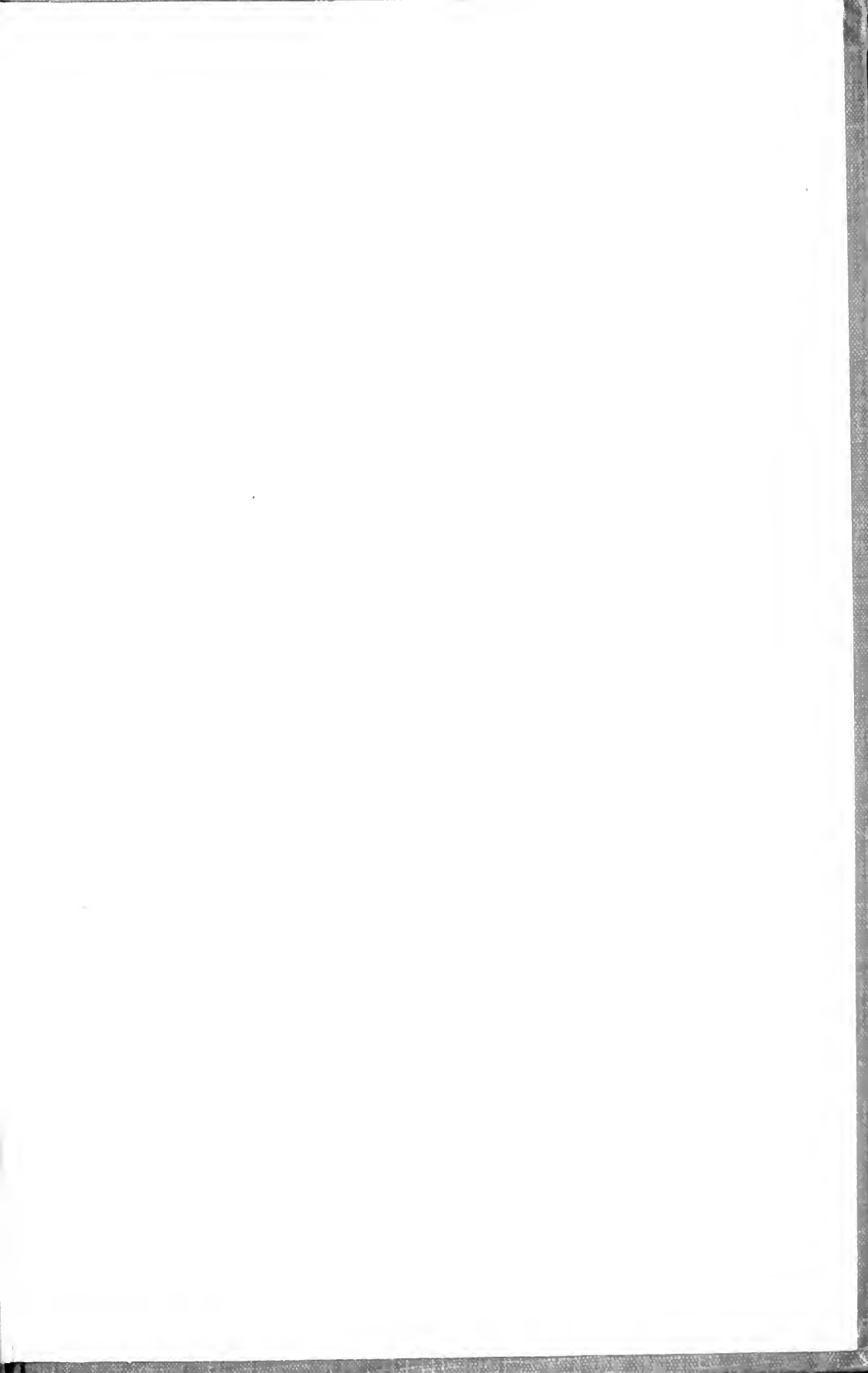
